DEVELOPING the Low Emission Development Strategy for the Industrial Sector in Bhutan



Under the framework of Low Emission Capacity Building (LECB) Programme, which is funded by the United Nations Development Programme (UNDP), we have been awarded the contract for developing the Low Emission Development Strategy for the Industrial Sector in Bhutan.

Our main task is to provide technical knowhow and capacity building and lead development of LEDS in the industrial sector for the Kingdom of Bhutan.

This contract is the second success outside Vietnam for the Climate/Clean Energy jointteam in NIRAS DK and RCEE-NIRAS and is going to be implemented from October 2014.

FINAL WORKSHOP for wrapping up The project "Support for the National Target Program on Climate Change with a Focus on Energy and Transport (TA-7779)"

After more than two years of implementation, the project "Support for the National Target Program on Climate Change with a Focus on Energy and Transport (TA-7779)" has now been finished. As authorized by the Ministry of Industry and Trade, the Industrial Safety and Environment Agency (ISEA) in collaboration with the Asian Development Bank has organized the Final National Workshop on the 12th September 2014 in Hoi An town, Quang Nam province .




Many important participants have been seen, including the reprentatives from Industry Safety techniques and Environment Agency (ISEA), Ministry of Trade and Industry; Ministry of Transportation; the Ministry of Natural Resources and Environment; Ministry of Planning and Investment; Ministry of Construction; Representatives from other relevant ministries and state agencies such as the Government Office, the State Bank of Vietnam,local Departments of Ho Chi Minh City, Da Nang, Thanh Hoa, Quang Nam; and also some representatives from donors such as GIZ, JICA, WB.

The main findings will be an important prerequisite for Vietnam to identify the adaptation measures and mitigation of greenhouse gas emissions in the energy and transport sector. All project's results and technical reports will be transferred to Ministry of Industry and Trade and the agencies involved.





DEVELOPMENT of Green Growth Action Plan for Da Lat and Quang Ninh



NIRAS Vietnam has just won a new contract for building up the Marginal Abatement Cost Curve (MACC) and developing the Provincial Green Growth Action Plan for 02 Provinces: Da Lat and Quang Ninh.

This contract is with the framework of "Strengthening mainstreaming the sustainable development and climate change into planning system" project funded by UNDP and coordinated by MPI.

The mission focuses on some main activities, including: i). Inventory and forecast of Greenhouse Gas Emissions, building up Emissions baseline of the basic scenario, ii). Building up the emissions abatement curve base on calculating the long-term marginal cost for each selected technology, (iii) Assist in completing the Green Growth Action Plan for Quang Ninh Province and Da Lat city.



NIRAS Vietnam in collaboration with Center of Energy and Green Growth Research (CEGR) is working on a project funded by KOIKA on Legal Framework of Vietnam Green Growth Strategy.

The consultant's team will assess the current legal framework in four sectors: Energy, Industry, Environment and Planning & Investment to propose possible improvements related to Vietnam Green Growth Strategy. Key findings will be presented for stakeholder consultation in January 2015.

A roundtable on reviewing the legal framework in Energy sector was successfully organized in Danang on November 28th 2014 and the consultation workshop on reviewing and assessment the Legal & institutional framework in 4 sectors: Energy, environment, industry and Planning & investment was held on January 8th 2015.

The project is led by Korea Environmental Institute (KEI) and coordinated by Ministry of Planning and Investment (MPI).

STUDY ON The Marginal Abatement Cost Curve (MACC) for Provinces: Quang Nam, Ben Tre, Bac Ninh

Under the framework of Supporting the Green Growth Strategy Implementation in Vietnam project - VGGS, Niras Vietnam and CEGR has signed the memorandum of understanding (MOU) for development of Provincial Green Growth Action Plan (PG GAP) including the study on Marginal Abatement Cost Curve (MACC) and awareness raising among authorities in the three selected provinces: Bac Ninh, Quang Nam, Ben Tre.

Thereby, the expert team has been working with related departments of 3 provinces for data collection training and data collecting.


Environment and consultant team of NIRAS Vietnam and CEGR.

NIRAS Vietnam got the contract for the Technical Service "Assessment of Energy Saving Potential in the Pulp and Paper Industry in Vietnam". The assignment will involve a general survey and assessment energy of use (electricity and primary fuel) in the pulp and paper industry; followed by preliminary energy audit for a number of selected facilities that are representative of the industry; and based on the results of an energy efficiency benchmarking exercise, carry out an assessment of energy saving potential in the pulp and paper industry.

This contract is under framework of Clean Production and Energy Efficiency Project (CPEE), which is sponsored by the World Bank. The CPEE is being implemented by the Energy Efficiency and Conservation Office (EECO) under the Department of Science, Technology and Energy Efficiency in MOIT's General Directorate of Energy.

This MOU was signed among KOICA - the Vietnam Green Growth Strategy project management unit, Ministry of Planning and Investment/ Department of Science Education National Resource and

Energy Audit

For Northeast Coal Cooperation



In December 2014, Niras Vietnam has signed 02 Energy audit contracts with total value of USD30,000 for 2 companies under Northeast Coal Corporation – The Ministry of Defence. EMS unit will conduct the energy audit at the North – Eastern Coal Processing Transport & Trading Company and Company no. 379with main tasks below:

- 1.1. Comprehensive Survey for the supply systems of power, heat, pneumatic devices and energy consumption.
- 1.2. Energy audit to the supply and consumption of energy, etc.
- 1.3. Installation of energy metering equipment for Electric equipment, fuel for transport vehicles at sites, workshop, production area, Monitoring to the measurement results in the necessary periods.
- 1.4. Analysis of energy savings potential in the condition of company.
- 1.5. Propose the practical solutions to reduce energy costs.
- 1.6. Calculation of economic efficiency by the application of energy-saving solutions for Company.

The contracts starts from 12/2014 and expected to finish by the end of March 2015.

Completed EnAudit Service

1. Energy audit for VIGLACERA Dong Trieu

In October 2014, Niras Vietnam has conducted energy audit for VIGRACERA Dong Trieu , Quang Ninh province, Vietnam.

VIGLACERA Dong Trieu JSC was established in 1965, with production area of approximately 236,400m2 . The main products of Vigracera Dong Trieu JSC are brick and decoration tile, the production capacity is designed up to 150 million units per year.

Energy audit will help Vigracera Dong Trieu JSC developing solutions to reduce energy cost and enhance Employee's awareness in energy saving. NIRAS Vietnam has done energy audits for other VIGRACERA's branch factories in previous years.

2. Energy Audit for Dorco Vina

Under the Agreement with Dorco Vina, Niras Vietnam has successfully completed the energy audit for Dorco Vina's factory.

Dorco Vina Co., Ltd. is a member of Dorco- the multinational organization founded in 1955 with headquarters in Korea. The main products are cutlery, kitchen utensils, razors; being exported to 118 countries around the world.

Dorco Vina was established on March 2008, with headquarters in Pho Noi A Industrial Zone, Hung Yen province. It has total 966 employees. Currently, the factory has two production lines with a capacity of 957.2 million units / year and 1,103 million / year.

Dorco Vina can achieve its target in saving energy costs with the energy saving measures identified in the energy audit report.





COMPREHENSIVE SURVEY

on Energy Efficiency Services Providers (EESPs)

NIRAS Vietnam will conduct comprehensive survey on Energy Efficiency Services Providers (EESPs) in Vietnam from September 2014 till February 2015.

The survey will identify and assess Energy Efficiency Service Providers (EESPs) in Vietnam to ensure that quality solutions are available to and trusted by the Small and Medium Enterprises (SMEs) and the lending banks financing Energy Efficiency investment projects.

The assignment is under the framework of the "Low carbon transition in the energy efficiency sector" (LCEE) project that supports Vietnam Energy Efficiency Programme (VNEEP) and consists of two components: The first supports Ministry of Industry and Trade (MOIT) in promoting energy efficiency in the Small and Medium Enterprises (SMEs) sector with a focus on the brick, ceramic and food processing industries while the second provides support to Ministry of Construction (MOC) in implementing the new energy efficiency building code (EEBC) for new large buildings. Low Carbon transition in the Energy Efficiency sector project (LCEE) is sponsored by DANIDA.
